 - We have it in the CA that if a Part-time member taught for 25 semesters then they should be on step 6. It is in an MOU for Part-time Faculty to identify themselves as having 25 semesters of teaching and that we, the MRFA and HR, are to work on a process to deal with them (i.e. find acceptable proofs that they could possibly obtain). We have to be ready for this by next year when it will start to effect long serving Part-time faculty.
 - We need to communicate this to Part Time faculty (before we do that Gerry will check on other options of proof)
