- (2) contributions through service on bicameral Governance Bodies including but not limited to:
 - Faculty Council Committees: Curriculum Committees, Agenda Committees, Faculty Review Committees or other standing Faculty Council Committees
 - MRFA Academic Liaison Committee or the MRFA Academic Policy and Governance Committee
 - MRU Board of Governors and its standing committees
- (3) Leadership in Advocating and Advancing Bicameral Governance at local, regional and national level
 - Championing bicameral governance initiatives which enhance faculty voices at Faculty Councils, the MRFA, General Faculties Council and its Committees, the Board of Governors
 - Leading major initiatives focused on bicameral governance locally, provincially and/or nationally
